- a. A list of documents required by Mexican Customs Will be sent to Mexican importer. These documents are necessary properly set up importer as a Customer with MX Broker.



### **US importer in United States:**

- a- Grant legal power to JOSE ANTONIO ZURITA DBA DYNAMIC SERVICES CO. To represent your company to make customs clearances before USCBP. (attached format)
- b- Form W-9 where the tax identification number is certified (Tax ID Number)
- c- Government issued identification of person signing the POA
- d- Security questionnaires to meet the requirements of the Security program C-TPAT
